Colleagues and Members of the Michigan Academy of Pediatric Dentistry,

Below are some updates on board activity and Pediatric Dentistry in the State.

- We have started our first membership cycle with the AAPD, collecting our dues. - Transitions Committee: We are actively looking for better ways to connect our members with pediatric dental residents. The committee is in the process of looking at several alternatives to our traditional meet-and-greet dinners before the meetings as they have recently been poorly attended.
- Legislative Update: You likely received an email from the Bureau of Professional Licensing (BPL) within the Department of Licensing and Regulatory Affairs (LARA) stating that the NEW Dentistry Administrative Rules went into effect. We previously informed our members that there was a significant change and error in these new rules that was caught by Dr. Dana Radtke. The change would have required full American Board of Pediatric Dentistry certification (written and oral boards) to become a licensed Pediatric Dentist in the state. Dr. Radtke worked with the lobbyists and legal counsel of the Council of Michigan Dental Specialists to make sure this was corrected before the rules were finalized. Thank you, Dr. Radtke. There are many other changes to the rules, including the fact that there are now 10 licensed specialties in the state.
- An email survey was sent out to the membership looking to engage membership in our planning of the Fall 2024 meeting. Thank you for your helpful feedback and responses. We are excited to try something different next fall.
